



## Log In & Win Sweepstakes Disclosure

### **\*Connexus Credit Union Log In and Win Sweepstakes Rules and Disclosures**

No purchase necessary. (1) Description of Sweepstakes - Connexus Credit Union (the "Sponsor") is offering "Log In and Win" (the "Promotion") and will award prizes via a random selection from eligible entrants. The Promotion begins at 12:00AM U.S. Central Standard Time ("CST") on April 1, 2018 and ends at 12:00 AM CST on May 1, 2018, ("Promotion Entry Period"). On May 10, 2018, winners will be randomly selected to win. By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. By participating in the Promotion, participants agree to release, discharge and hold harmless Promotion Entities (defined below) from any and all damages whether direct or indirect, which may be due to or arise out of participation in the Promotion or any portion thereof, or the acceptance, use/misuse or possession of prizes. (2) Eligibility - The Promotion is open only to individuals who reside in the United States and are eighteen (18) years of age or older at the time of entry. Log in to Connexus Digital Banking between 4/1/18 and 4/30/18. (ii). Log in to the Connexus App for Apple or Android between 4/1/18 and 4/30/18. (iii). Your entry must be postmarked by April 30, 2018, and received no later than May 7, 2018. There is a limit of one (1) Entry per person regardless of Entry method. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different/duplicitous identities or any other method will void that entrant's entries and that entrant may be disqualified. Entries that are incomplete, late, lost, postage-due, mutilated, illegible or contain irregular or invalid information, or are corrupted in any way are void and will not be eligible.
